<u>Determination of first ranked bid when applying Margins of Preference for procurement of Goods</u>

The purpose of this Circular is to guide public bodies on the methodology to be adopted to determine the first ranked bid when applying the margins of preference (MOP) set out in Directive 49 after assessing the substantial responsiveness of the bids received.

2. The methodology to be used when different bidders are eligible for different rates of MOP is given below. The same methodology applies when there is a single rate of MOP.

Step 1

For evaluation purposes only, discount each bidder's price by their respective applicable rate of MOP.

Step 2

Rank the bids by starting from the lowest.

Step 3

Select the first ranked bidder for award at the price **quoted**.

- 3. Below is an example where the scenario is as follows:
 - Bidders D, E and F are not eligible to any MOP
 - Bidder A is eligible for an MOP of 40%
 - Bidder B is eligible for an MOP of 30%
 - Bidder C is eligible for an MOP of 20%

- 4. Therefore after application of margin of preference, Bidder A is the first ranked bidder and should be considered for selection of award of contract at the bid price of Rs 1600.
- 5. The applicable amount of MOP during evaluation through the e-procurement system (e-PS) must be entered manually with the negative sign as shown in the Table above in order to obtain the discounted price for ranking and comparison.
