Public Procurement Act 2006 – Templates for Notification of Award

As you are aware, section 40(3) of the Public Procurement Act provides that -

"A public body shall notify the successful bidder in writing of the selection of its bid for award, and a notice in writing shall be given to other bidders, specifying the name and address of the proposed successful bidder and the price of the contract."
